Time to settle down with a good read

This month is an interesting month for data analysis and report reading. So, time to settle down with a cup of tea and digest some of the findings in two interesting sets of reports:

- 1) The latest National Institute for Health and Care Excellence (NICE) impact report on maternity and neonatal care highlights some interesting findings on the impact of NICE guidance.
- 2) The NHS Improvement bi-annual official statistics reports include a raft of data sets, trends and analysis on patient safety incident reporting. The number of incidents reported to the NRLS for England continues to increase. Incident categories help us understand that certain types of incident are more common than others. Nationally, the top reported from April 2017-19 were 'patient accident', 'implementation of care and ongoing monitoring/review', 'access, admission, transfer, discharge' and 'medication.' which show a great connection to the PSC workstreams.

Read more about these, as well as some exciting new workstreams below.

I'd also like to thank East of England Leadership Academy for their support in funding another Measurement for Improvement masterclass (delivered in October), as well as the Human Factors masterclass coming up on 20 November. It is a great sign of commitment from individuals and organisations to learn that these classes are nearly full or are holding waiting lists.

➤ NEW - Medicine Safety Improvement Programme

The Medicine Safety Improvement Programme (MedSIP) aims to reduce errors in the administration of medicines in care homes, thus improving the safety and experience of care.

This month, the first phase of the programme will begin, which will involve mapping out what is working around medicines safety in care homes, exploring the nature and scale of medication errors and assessing the quality improvement (QI) capabilities of care home staff. This will allow us to understand current delivery, the nature and scale of the issue and identify potential medicine safety 'test sites' and interventions next year.

We will be engaging with key stakeholders, including patient and public involvement (PPI) groups, clinical commissioning groups, local authority and care home providers, primary care networks and many more.

We look forward to updating you on our progress with this exciting new workstream in the near future.

➤ Maternity and Neonatal Safety Improvement Programme

The Maternity and Neonatal Safety Improvement Programme (MatNeoSIP) is the new name for the former Maternity and Neonatal Patient Safety Collaborative. The programme supports continuous and sustainable improvement in maternity and neonatal units through evidence-based QI methodology.

Trusts involved in wave 3 of the MatNeoSIP will be attending a two-day learning set in November to develop practical skills in: the model for improvement; situational awareness and human factors; the 'refine and scale up' phase, and much more.

This will offer an opportunity for improvement teams to do group work and refine their improvement projects in areas such as:

- Improving the proportion of smoke-free pregnancies
- Improving optimisation and stabilisation of very preterm infants
- Detection and management of diabetes in pregnancy
- Detection and management of neonatal hypoglycaemia

We look forward to seeing colleagues involved in MatNeoSIP in November!

➤ E-learning module – Improving safety culture on the labour ward

National publications such as the Francis Report and Berwick Review emphasise the need for human factors principles and practices to drive improvement in quality and safety in the NHS.

In 2017 Eastern, West Midlands and East Midlands PSCs, in association with Health Education England, called for expressions of interest to gather a range of bespoke human factors projects, designed specifically to tackle an issue relating to a priority area in the NHS.

One of the successful submissions was from Norfolk and Norwich University Hospital NHS Foundation Trust who were keen to develop a human factors e-learning package, built on evidence-based national recommendations specific to maternity. After 18 months of hard work from a partnership of midwives, patients and doctors, the e-learning resource is now available. It helps develop personal and team knowledge of human factors in areas such as decision making, communication, team working and conflict resolution.
